- o The clinic will collect, use and disclose information about you for the following purposes:
 - o To assess your health concerns
 - o To provide health care
 - o To advise you of treatment options
 - o To establish and maintain contact with you
 - o To send you new letters and other information mailings
 - o To remind you of upcoming appointments
 - o To communicate with other treating health care providers
 - o To allow us to efficiently follow-up for treatment, care and billing

- o To comply with legal and regulatory requirements of our regulatory body, the Board of Directors of Drugless Therapy-Naturopathy acting under the authority of the Drugless Practitioners Act
- o To invoice for goods and services
- o To process credit card payments
- o To collect unpaid accounts
- o To assist this clinic to comply with all regulatory requirements
- o To comply generally with the law
- o To allow potential purchasers, practice brokers or advisors to conduct an audit in preparation for a practice sale.
